Most families have at least one motor vehicle, and a significant percentage are financed. All cars need fuel, insurance, registration, tyres, and servicing. The ATO have established salary packaging which allows employees to pay all these costs before tax, increasing take home pay.

It's that simple ! and we do all the management.

An Example – Pay before tax and save!

An employee on \$50,000 PA travelling 15,000 kms each year in a small \$20,000 hatch will save \$2,049.

That's nearly \$40 per week for paying the same bills before tax!

Great News for all Employees

The ATO have lowered FBT rates for vehicle travelling less than 15,000 kms !

The Australian Government is currently in the process of converting the table of rates they use to calculate the FBT to a flat 20%. Prior to these changes most Australians travelled less than 15,000km's per year and were on a Statutory rate of 26%. This has already changed to 20%.

This means that many Australians are now 6% better off.

our documents

All of our documents are in plain english. We have listened to what customers want and have designed documents that contain not just the required information but information in a format that everyone can understand.

For example

“what will be missing from my current take home pay”

Our quotes contain all required information that any employee would need to make an informed decision and in big, bold text is the one piece of information most sort after; “what will this car cost me per pay after tax” or “what will be missing from my current take home pay”. Without this figure a decision can not be made.

This principle also extends to our tax invoices and end of year FBT reports to employers.

We have all employee required forms posted on our website including; reimbursement claim forms, FBT km declarations and our package cancellations document.

our process

Our service must be as simple to institute as possible. For this reason we do all the work for you. Once the rollout email has been distributed we will take the calls and book the information sessions. We will answer all questions on Salary Packaging. When a package is established we will issue a simple tax invoice showing the before tax, after tax, GST components, and the total. These funds are simply sent to us and we manage and pay all the vehicle accounts. And at the end of the FBT year we send you a detailed FBT report. **Simple.**

security +

The employer is never at risk. All vehicles are managed under the ATO required novated lease. This is simply a finance contract for the lease with a novation deed attached. The deed binds the three parties together; whilst the employee works for the employer the employer through a salary sacrifice arrangement will pay the payments for the vehicle to the leasing company. This means that if the employee leave work for any reason the deed is automatically broken and the employee is then responsible to make the finance payments. **NO RISK to the employer.**

+ This provides the perfect alternative to company vehicles. No more management, no more receipts and if an employee leaves the vehicle leaves with them.
